NOTICE OF A RESCHEDULED SEATTLE CITY COUNCIL PUBLIC HEARING REGARDING COUNCIL BILL 121094 – INTERIM REGULATION PROHIBITING NEGATIVE USE RESTRICTIONS ON GROCERY STORES AND PHARMACIES

On October 28, 2025, the City passed Council Bill 121094, which establishes interim regulations prohibiting negative use restrictions on grocery stores and pharmacies. Negative use restrictions are covenants, deed restrictions, leases or other private agreements that prohibit the use of a property as a grocery store or pharmacy. The bill would allow some reasonable exceptions to the prohibition on negative use restrictions. For example the prohibition on negative use restrictions would not apply: (1) to negative use restrictions already in place, (2) when a grocery store or pharmacy is relocating to a site within a half-mile of a current location, and (3) for restrictions imposed within an individual shopping center that limit the location of a competing grocery store or pharmacy just within that center. Violations of the negative use restriction would be enforced as civil proceedings through the Land Use Code with potential fines of up to \$1,500 / day.

The bill was passed pursuant to RCW 36.70A.390 and, unless renewed, will expire one year after passage.

A public hearing was originally noticed for December 2. The public hearing has been rescheduled to December 16.
