GOAL OF SPP

On November 4, 2014, Seattle voters approved a four-year, \$58 million property tax levy to provide "accessible high-quality preschool services for Seattle children designed to improve their readiness for school and to support their subsequent academic achievement."

(City of Seattle Proposition 1B, preamble).



SPP STUDENTS

- Priority enrollment for 4-year-olds
- Open to 3-year-olds from families 300% FPL and below (\sim \$6,000/month for a family of 4)
- Sliding scale for tuition (free for many)

DEMONSTRATION PHASE (2015-18)


- 1. Which elements originally adopted for SPP need to be in place to provide high quality preschool?

YEAR ONE: SNAPSHOT



LESSONS LEARNED IN YEAR ONE

- Seattle holds a common vision for access to high quality preschool for all.
- Providers and families deeply value the continuity of care.
- One size does not fit all.
- 4. Challenges remain for providers to join SPP, including moving to full-day programming, space, child selection policies and reimbursement structure.

POLICY PROPOSALS

Continuity of Care:

- 1. Creating quality transitions into Kindergarten
- 2. Minimizing transitions for children and families
- 3. Aligning with specialized program requirements

Organizational eligibility:

- 1. Two classroom minimum
- 2. Curriculum waiver process
- 3. Classroom composition

CONTINUITY OF CARE: SCHOOL CONTINUITY AMENDMENT

Implementation Plan, pp. 15-16, Selection and Enrollment.

Proposed additions in red:

- Children whose sibling is currently enrolled in SPP or in a school building where an SPP classroom is housed and would be concurrently enrolled (in the same year) with the sibling will be prioritized.
- 2. Children living in the same SPS middle school attendance area as an SPP classroom will receive priority over children living in other parts of the City. For SPP classrooms located in school buildings, priority will be given to children who are eligible to continue in that school for kindergarten.

CONTINUITY OF CARE: CAREGIVER CONTINUITY AMENDMENT

Implementation Plan, p. 16, Provider Agency-Managed Selection and Grandfathering

Children meeting SPP's eligibility criteria who are currently enrolled with a contracted agency may be grandfathered into the program. In the first year of a site's SPP contract, all eligible children will be eligible for grandfathering. Thereafter, the percentage of children grandfathered into program classrooms will be determined on an annual basis by DEEL.

CONTINUITY OF CARE: PROGRAMMATIC ALIGNMENT AMENDMENT

Proposed addition in red:

SPP agencies with SPP classrooms that offer Head Start, ECEAP, dual language programs, or special education services may select a percentage of the children for these classrooms. The agency-selected children must meet SPP's eligibility criteria. The percentage of agency-selected participants will be determined on an annual basis by DEEL.

ONE SIZE DOES NOT FIT ALL: ORGANIZATIONAL ELIGIBILITY AMENDMENTS

Action Plan, p. 11, proposed deletion in purple:

In order to participate in the program, organizations must commit to:

- Providing two or more preschool classrooms
- Ensuring that all children in contracted classrooms are Seattle residents
- adhering to the program standards listed herein.

ONE SIZE DOES NOT FIT ALL: CURRICULA AMENDMENT

Action Plan, p. 14, proposed deletion in purple: After 2018, a curriculum waiver process will be considered for high-quality providers.
