1. BILL SUMMARY

Legislation Title: A RESOLUTION relating to sustainable procurement; encouraging the Executive to coordinate strategic planning for and implementation of performance standards and/or baseline practices to achieve far-reaching and systemic sustainable procurement outcomes to protect the environment and public health; and requesting a report by June 30, 2023.

Summary and Background of the Legislation: The City of Seattle's Finance & Administrative Services Department's <u>website</u> describes its Green Purchasing Program as a cooperative effort among City departments to promote environmental stewardship and reduce greenhouse gas emissions when buying goods, materials, services and capital improvements. As shown on the website, the City's Green purchasing policies and requirements address a broad range of topics and practices including climate change, fleet management plans, landscape and grounds management, and sustainable buildings. In addition, FAS promulgated a Sustainable Purchasing Policy, effective April 22, 2021.

This resolution would endorse the April 2021 Sustainable Purchasing Policy and request that the Executive convene as soon as possible the FAS-led Green Team to coordinate planning for and implementation of sustainable purchasing, including establishment of baseline practices and/or performance standards. The resolution requests that the Green Team establish specific practices and standards for procurement of chemicals, construction materials, energy, and natural resources for implementation, to the extent feasible. The resolution requests that the Executive file a report with the Clerk by June 30, 2023 on baseline practices and performance standards for the sustainable purchasing program, including fiscal impacts and potential funding sources.

The financial impacts of new sustainable practices and standards for procurement of chemicals, construction materials, energy, and natural resources for implementation would vary depending upon the scope and scale of each procurement. The resolution requests that that the Executive include the fiscal impacts of and potential funding sources for implementing baseline practices and performance standards in their report.

If the legislation is not implemented, the Executive will continue with its current process for convening the FAS-led Green Team to support the existing Green Purchasing Program. That program does not currently include a comprehensive set of baseline practices and performance standards, as requested by this Resolution.

Numerous studies have shown that people of color, disadvantaged, vulnerable, low-income, marginalized, and indigenous peoples are disproportionately burdened by environmental threats that contribute to health disparities. Sustainable purchasing policies that include baseline practices and performance standards may reduce these environmental impacts and disparities by using and increasing demand for less toxic alternatives to products and encouraging investment in renewable resources.

This resolution is intended to encourage the FAS-led Green Team to develop baseline practices and performance standards, some of which could establish and maintain City actions that would decrease carbon emissions.

Implementation of sustainable purchasing practices and/or meeting related performance standards could increase the City's ability to adapt to climate change by preparing for a future in which businesses seek and/or are required to address climate change impacts by discontinuing production and/or distribution of environmentally harmful chemicals and products that increase greenhouse gas emissions.

This resolution is intended to encourage development and implementation of baseline practices and performance standards which would increase accountability for the City's sustainable purchasing decisions.
