1. BILL SUMMARY

Legislation Title: A RESOLUTION setting the public hearing on the petition of Central Puget Sound Regional Transit Authority (Sound Transit) for the vacation of the southern portion of the alley in Block 3, Shelton’s Addition to the City of Seattle in the block bounded by NE 45th Street, Roosevelt Way NE, NE 47th Street, and 11th Avenue NE, in the University Community Urban Center area of Seattle, according to Chapter 35.79 of the Revised Code of Washington, Chapter 15.62 of the Seattle Municipal Code, and Clerk File 314496.

Summary and Background of the Legislation: This resolution sets the public hearing date for the petition of Central Puget Sound Regional Transit Authority (Sound Transit) for the vacation of the alley in Block 3, Shelton’s Addition to the City of Seattle; this is the south a portion of the alley in the block bounded by NE 45th Street, Roosevelt Way NE, NE 47th Street, and 11th Avenue NE as contained in Clerk File 314496 and as required by the Revised Code of Washington and the Seattle Municipal Code.
