WHEREAS, the Executive Director and staff of the Seattle City Employees' Retirement System administer the City's defined benefit retirement plan providing a pension benefit to eligible City employees and their beneficiaries; and
12	WHEREAS, the Seattle Human Resources Department currently administers the City of Seattle
13	Voluntary Deferred Compensation Plan and Trust, a defined contribution plan that City
14	employees may utilize to defer wages on a pre-tax basis to save for retirement; and
15	WHEREAS, consolidating the City's administrative functions of both the Seattle City
16	Employees' Retirement System and the City of Seattle Voluntary Deferred Compensation
17	Plan and Trust to a single department is expected to achieve resource efficiencies and
18	create a more comprehensive service for employees planning for their retirement; and
19	WHEREAS, consolidating functions is best achieved by transferring the administration of the
20	City of Seattle Voluntary Deferred Compensation Plan and Trust from the Seattle
21	Department of Human Resources to Seattle Retirement designated pursuant to this
22	ordinance; NOW, THEREFORE,
23	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
24	Section 1. The function of administering the City of Seattle Voluntary Deferred
25	Compensation Plan and Trust shall be transferred from the Seattle Department of Human

1	Resources to Seattle Retirement designated under this ordinance. All authorities, contracts,
2	obligations, equipment, records, assets, liabilities, appropriations, budget authority, positions,
3	and incumbents previously held by the Seattle Department of Human Resources in connection
4	with the City of Seattle Voluntary Deferred Compensation Plan and Trust shall also transfer to
5	Seattle Retirement. However, nothing in this ordinance shall diminish the authority or legal
6	obligations of the governing Plan Committee of the City of Seattle Voluntary Deferred
7	Compensation Plan and Trust, or affect the assets held in trust on behalf of participants and
8	beneficiaries of the City of Seattle Voluntary Deferred Compensation Plan and Trust.
9	Section 2. Section 4.36.070 of the Seattle Municipal Code, last amended by Ordinance
10	125109, is amended as follows:
11	4.36.070 Definitions—"R" through "Z"
12	Unless a different meaning is plainly required by the context the terms used in this ((chapter))
13	<u>Chapter 4.36</u> shall have the following meanings:

15	"Retirement system" means the "City Employees' Retirement System" provided for in
16	Section 4.36.080 and the system of death benefits established therein.
17	"Seattle Retirement" means the department authorized to provide administrative services
18	for the Seattle City Employees' Retirement System and the City of Seattle Voluntary Deferred
19	Compensation Plan and Trust.
20	Section 3. Section 4.36.505 of the Seattle Municipal Code, last amended by Ordinance
21	125109, is amended as follows:
