COUNCIL BILL\_

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

### BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$26,073,280.54 on Summit mechanical warrants numbered 4002737926 – 4002740715 plus manual or cancellation issues for claims, E-Payables of \$66,225.43 on Summit 9000026018 – 9000026085 and Electronic Financial Transactions (EFT) in the amount of \$44,131,025.74 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$42,971,085.40 on City General Salary Fund mechanical warrants numbered 51263932 – 51264746 plus manual warrants, agencies warrants, and direct deposits numbered 450001 – 462478 representing Gross Payrolls for payroll ending date Nov. 1, 2016 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council Nov. 10, 2016 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.

Section 3. That any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.
