14	RCW 42.24.180 and approved consistent with remaining appropriations in the current Budget as
15	amended.
16	Section 2. Payment of the sum of \$56,951,704.59 on City General Salary Fund
17	mechanical warrants numbered 51389175 – 51390035 plus manual warrants, agencies warrants,
18	and direct deposits numbered 360001 – 362949 representing Gross Payrolls for payroll ending
19	date August 29, 2023, as detailed in the Payroll Summary Report for claims against the City that
20	were reported to the City Council September 07, 2023, is approved consistent with remaining
21	appropriations in the current budget as amended.
22	Section 3. RCW 35.32A.090(1) states, "There shall be no orders, authorizations,
23	allowances, contracts or payments made or attempted to be made in excess of the expenditure
24	allowances authorized in the final budget as adopted or modified as provided in this chapter, and
25	any such attempted excess expenditure shall be void and shall never be the foundation of a claim
26	against the city."
