1. BILL SUMMARY

Legislation Title:

AN ORDINANCE extending the duration of the block-the-box and transit-only lane camera enforcement programs; amending Ordinance 126183; declaring an emergency; and establishing an immediate effective date; all by a 3/4 vote of the City Council.

Summary and Background of the Legislation:

In 2020, City Council passed Ordinance 126183, authorizing the use of automated traffic safety cameras to enforce block-the-box and transit-only lane enforcement. This legislation included an expiration date of June 30, 2023, as proscribed by State law in effect at that time (Engrossed Substitute House Bill 1793, Chapter 224, Laws of 2020). In 2022, the State extended authorization for these camera programs to June 30, 2025 (Engrossed Substitute Senate Bill, Chapter 182, Laws of 2022). This legislation would amend Ordinance 126183 to reflect the June 30, 2025 expiration date.

This legislation includes findings to declare that this ordinance is a public emergency ordinance which will take effect immediately upon passage by a 3/4 vote of the City Council and approval by the Mayor. This provision will allow for continued authorization of block-the-box and transit-lane camera enforcement without a lapse in local authority. If proposed as non-emergency legislation, the ordinance would become effective 30 days after approval by the Mayor, which would occur after the June 30, 2023 expiry date.

The City currently operates cameras at four block-the-box intersections and five transit-only lane locations.
