2	Section 1. The plat of "Seattle Modern Living on Willow," a platting of portions of the
3	Southeast Quarter of the Northeast Quarter of Section 27, Township 24 North, Range 4 East,
4	W.M., all in King County, Washington, is legally described as follows:

20	of the Seattle Department of Construction and Inspections, the City Council makes the following
21	findings:
22	A. The final plat is in substantial conformance with the approved preliminary plat;

24	B. When both the King County Assessor and King County Finance Division have
25	affixed their certifications as required by RCW 58.17.160(4), the requirements of State law and
26	City ordinances that were in effect at the time of preliminary plat approval will also have been
27	satisfied by the subdivider; and

The public use and interest will be served by the establishment of the plat, and the C. plat makes appropriate provision for the public health, safety, and general welfare.

Section 3.
