Budget Process Overview

- Interim: Governor's Office (OFM) budget creation process
- January: Session begins, Governor's budget (OFM) read in as 2025-27 Operating, Capital
 & Transportation Bill, public hearings held
- February: Budget requests submitted to legislators
- March/April: Additional revenue forecast -> budgets (& revenue proposals) released -> public hearings/exec -> pass of floor -> Conference Committees (receive other chamber's bill refuse to concur establish conference committee)
- April: Conference committee meets & negotiates
- Pre Sine Die: Adopt conference committee reports (aka final budgets)
- Post session: Governor signs the budgets into law
- July 1: State fiscal year begins



Operating Revenue Proposals

House

- <u>Financial intangibles tax</u> 0.8% tax on financial intangible assets like stocks, bonds, mutual funds and index funds with the first \$50 million exempt.
- <u>Property tax lift</u> Allows for exemptions to the 1% cap on property tax growth based on inflation and population growth up to 3%.
- <u>B&O surcharge</u> 1% B&O surcharge on businesses with taxable income of over \$250 million. Also increases financial institutions B&O surcharge from 1.2% to 1.9%.

Senate

- <u>Financial intangibles tax</u> 1% tax on financial intangibles held by individuals with more than \$50 million of these assets.
- <u>Payroll expense tax</u> 5% tax on the amount of payroll above the social security threshold (currently \$176,100). Limited to companies with \$7 million or more in payroll expenses.
- <u>Property tax lift</u> Raises the property tax growth limit from 1% to combined rate of population growth plus inflation.
- Repealing tax preferences Repeals 20 tax exemptions for things like in-state hauling, gold bullion, and prescription drug wholesalers.
- Sales tax cut Decrease in state sales tax from 6.5% to 6%.

Operating - Housing/Homelessness

Senate

- \$200 million for covenant homeownership program.

Operating - Other

- \$165 million transfer from PWAA to state general fund in FY 2026 (\$165 transfer back to PWAA from general fund in FY 2027).

- \$288 million transfer from PWAA to state general fund in FY 2026.
- \$6 million to support local governments in siting and permitting clean energy projects.
- \$20.5 million to assist owners of public buildings conduct energy audits.



House Transportation Revenue

- Nine cent gas tax increase, indexed to inflation.
 - Cities would get 6%
- Annual highway use fee based on car's fuel economy
- Vehicle sales tax increase from 0.3% to 1%

Senate Transportation Revenue

- Six cent gas tax increase (no city share)
- 0.3% sales tax transfer from general fund
- EV registration fee increase
- Luxury vehicle tax
- Rental car and peer to peer car sharing sales tax increase
- Drivers license fee increase
- \$10 traffic infraction assessment
- 10% e-bike surcharge
- \$1 per attendee assessment on large events (over 20k attendees)
- Other fee increases

Transportation

Senate

- \$83.3 million for Safe Routes to Schools grants
- \$87 million for Pedestrian and bicycle safety
- \$8 million to address homeless encampments on state-owned rights-of-way.

- \$83.3 million for Safe Routes to Schools grants
- \$82 million for Pedestrian and bicycle safety:
- \$9.2 million to address homeless encampments on state-owned rights-of-way (includes \$1 million dedicated for Seattle)
