11	transactions (EFT) in the amount of \$30,247,300.15 are presented to the City Council under
12	RCW 42.24.180 and approved consistent with remaining appropriations in the current Budget as
13	amended.
14	Section 2. Payment of the sum of \$63,713,484.24 on City General Salary Fund
15	mechanical warrants numbered 10375125 – 10375429 plus manual warrants, agencies warrants,
16	and direct deposits numbered 0000001 – 1002216 representing Gross Payrolls for payroll ending
17	date November 5, 2024, as detailed in the Payroll Summary Report for claims against the City
18	that were reported to the City Council November 14, 2024, is approved consistent with
19	remaining appropriations in the current budget as amended.
20	Section 3. RCW 35.32A.090(1) states, "There shall be no orders, authorizations,

22	allowances authorized in the final budget as adopted or modified as provided in this chapter, and
23	any such attempted excess expenditure shall be void and shall never be the foundation of a claim
