1. BILL SUMMARY

- 1. Legislation Title:** A RESOLUTION related to The City of Seattle’s Comprehensive Emergency Management Plan (CEMP); adopting the CEMP Introduction, Emergency Operations Plan, Continuity of Government Plan, and Emergency Support Function #14 – Transition to Recovery, including 2017 revisions.
- 2. Summary and background of the Legislation:**
This legislation is necessary to meet Revised Code of Washington (RCW) 38.52.070 and Seattle Municipal Code (SMC) Section 10.02.050 requiring a Comprehensive Emergency Management Plan (CEMP) is kept current. The Emergency Operations Plan (EOP), Continuity of Government Plan (COG) and Emergency Support Function (ESF) #14 - Transition to Recovery include 2017 Revisions.

CEMP Introduction – The CEMP Introduction provides an overview of the CEMP planning organizational structure and introducing the City emergency management program, functions, and doctrine.

Emergency Operations Plan – The EOP provides the strategies and guidance for how the City responds to and manages emergencies and disasters.

Continuity of Government Plan – The COG represents the City’s primary policy guidance for continuity of government and continuity of operations under circumstances that necessitate extraordinary measures.

Emergency Support Function #14 – Transition to Recovery. ESF #14 builds a bridge from the emergency response phase to the recovery phase and synching up with the guidance and coordination structure laid out in the City of Seattle Disaster Recovery Framework.
