CITY OF SEATTLE ORDINANCE 127058

COUNCIL BILL 120814

AN ORDINANCE appropriating money to pay certain claims for the week of July 1, 2024 through July 5, 2024 and ordering the payment thereof; and ratifying and confirming certain prior acts.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$24,035,024.56 on PeopleSoft 9.2 mechanical warrants numbered 4100818436 – 4100820387 plus manual or cancellation issues for claims, e-payables of \$114,561.75 on PeopleSoft 9.2 9100014596 – 9100014610, and electronic financial transactions (EFT) in the amount of \$107,792,003.91 are presented to the City Council under RCW 42.24.180 and approved consistent with remaining appropriations in the current Budget as amended. Section 2. Payment of the sum of \$144,709,423.69 on City General Salary Fund mechanical warrants numbered 51403715 – 51405705 plus manual warrants, agencies warrants,

18 and direct deposits numbered 280001 – 283162 representing Gross Payrolls for payroll ending

Section 3. RCW 35.32A.090(1) states, "There shall be no orders, authorizations,

any such attempted excess expenditure shall be void and shall never be the foundation of a claim
against the city."
