7	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
8	Section 1. Payment of the sum of \$23,812,858.04 on PeopleSoft 9.2 mechanical warrants
9	numbered 4100856973 – 4100861136 plus manual or cancellation issues for claims, e-payables
10	of \$64,178.72 on PeopleSoft 9.2 9100014809 – 9100014825, and electronic financial
11	transactions (EFT) in the amount of \$65,570,207.39 are presented to the City Council under
12	RCW 42.24.180 and approved consistent with remaining appropriations in the current Budget as
13	amended.
14	Section 2. Payment of the sum of \$62,230,267.52 on City General Salary Fund
15	mechanical warrants numbered 10368807 – 10369236 plus manual warrants, agencies warrants,
16	and direct deposits numbered 00001 – 13126 representing Gross Payrolls for payroll ending date
17	September 24, 2024, as detailed in the Payroll Summary Report for claims against the City that
18	were reported to the City Council October 3, 2024, is approved consistent with remaining
19	appropriations in the current budget as amended.
20	Section 3. RCW 35.32A.090(1) states, "There shall be no orders, authorizations,
21	allowances, contracts or payments made or attempted to be made in excess of the expenditure
22	allowances authorized in the final budget as adopted or modified as provided in this chapter, and
23	any such attempted excess expenditure shall be void and shall never be the foundation of a claim

against the city."

1	Section 4. Any act consistent with the authority of this ordinance taken prior to its
2	effective date is ratified and confirmed.
3	Section 5. This ordinance shall take effect and be in force 30 days after its approval by
4	the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
5	shall take effect as provided by Seattle Municipal Code Section 1.04.020.
