**CITY OF SEATTLE** 1 **ORDINANCE** 124805 2 COUNCIL BILL 118432 3 4 AN ORDINANCE approving and confirming the plat of "Valentine Homes" in the portions of 5 Northwest 1/4 of Section 9, Township 24 North, Range 4 East, W.M. in King County, 6 7 Washington. 8 9 WHEREAS, a proposed plat of "Valentine Homes" has been submitted for approval (DPD 10 Subdivision Application No. 3012372); and WHEREAS, a proposed plat of "Valentine Homes" includes an easement to The City of Seattle 11 12 for electrical purposes; and WHEREAS, following review and recommendations by the various City departments that have 13 jurisdiction in this matter and a public hearing by the Hearing Examiner of The City of 14 Seattle, the Hearing Examiner approved the preliminary plat of "Valentine Homes" on 15 16 June 25, 2014; and WHEREAS, the Director of Transportation and the Director of Planning and Development have. 17 subject to Council approval, approved the final plat for the unit lot subdivision and have 18 reported that the final plat now meets all of the requirements of the State platting law 19 (Chapter 58.17 RCW) and of the Seattle Municipal Code (SMC Chapter 23.22), except 20 for the execution of the required certifications by the King County Assessor and the King 21 County Finance Division; and 22 WHEREAS, the Director of Transportation and the Director of Planning and Development report 23 that the plat of "Valentine Homes," a copy of which is in Clerk File 312125 is now 24 complete and ready for City Council approval; NOW, THEREFORE, 25 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS: 26

With respect to the plat of "Valentine Homes", together with any interest in 21 abutting streets, as executed by Valentine Communities LLC, a Washington Limited Liability 22 Company, and approved by the Director of Transportation and the Director of Planning and 23 Development, the following findings are hereby made: 24 The final plat of the unit lot subdivision is in substantial conformance with the 25 (a) 26 approved preliminary plat of the unit lot subdivision, and When both the King County Assessor and King County Finance Division have 27 (b) affixed their certifications as required by RCW 58.17.160(4) the requirements of State law and 28 City ordinances that were in effect at the time of preliminary plat approval will also have been 29 satisfied by the subdivider; and 30

(c) The public use and interest will be served by the establishment of the unit lot subdivision, and the plat makes appropriate provision for the public health, safety, and general welfare.

Section 3. The plat of "Valentine Homes," a subdivision of portion of the North West Quarter of Section 9, Township 24 North, Range 4 East, W.M., King County, Washington, is in all respects approved and the plat confirmed and accepted, subject to certification by the King County Assessor and King County Finance Division, and the City Clerk is hereby authorized and directed to execute a certificate upon the face of such plat attesting to the approval thereof as evidenced by enactment of this ordinance.
