

Her approach to nutrition is deeply rooted in cultural tradition, bringing people together around shared meals as a way to nourish ourselves and celebrate life. Leika is particularly passionate about working towards resolving issues of social injustice that lead to health disparities. To do this, she collaborates with community organizations to actively find solutions that can uplift the community and reduce suffering resulting from systemic oppression. She has a wide variety of experiences working with diverse cultures and presenting nutrition in a way that is relevant and meaningful. She recently served on the Community Partner Steering Committee as a representative for Tilth Alliance (formerly Seattle Tilth) as part of the Mayor's Environmental Equity Initiative. When Leika is not cooking and eating with the community, she can be found playing Capoeira or hosting an event at the Union Cultural Center where her and her husband manage a cultural arts studio with their two children.
