COUNCIL BILL 118431

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$22,613,995.82 on Summit mechanical warrants numbered 4002518185 – 4002521159 plus manual or cancellation issues for claims, E- Payables of \$124,502.86 on Summit 9000020874 – 9000020944 and Electronic Financial Transactions (EFT) in the amount of \$28,804,347.95 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. That any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.






