ORDINANCE 126038

COUNCIL BILL 1197 36

AN ORDINANCE appropriating money to pay certain audited claims for the week of January 13, 2019 through January 17, 2019 and ordering the payment thereof.

**BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

Section 1. Payment of the sum of \$41,825,267.55 on PeopleSoft 9.2 mechanical warrants numbered 4100303211– 4100306422 plus manual or cancellation issues for claims, E-Payables of \$178,139.07 on PeopleSoft 9.2 9100005361– 9100005426 and Electronic Financial Transactions (EFT) in the amount of \$39,972,792.66 are presented for ratification by the City Council per RCW 42.24.180.


Section 2. Any act consistent with the authority of this ordinance taken prior to its effective date is hereby ratified and confirmed.

1           Section 3. This ordinance shall take effect and be in force 30 days after its approval by  
2 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it  
3 shall take effect as provided by Seattle Municipal Code Section 1.04.020.


