Legislation Title: A RESOLUTION designating the monthly President Pro Tem of the City Council of The City of Seattle for 2016-2017 and superseding Resolution 31644.

Summary and background of the Legislation:

This resolution updates the established 2016-2017 schedule for members of the City Council that are assigned and designated to serve as President Pro Tem, according to Rule I.D of the General Rules and Procedures of the City Council. On September 25, 2017, the Full Council approved by a two-thirds supermajority, a motion to temporarily suspend section I.D.1 of the General Rules and Procedures of the City Council to allow the adoption of a Resolution modifying the monthly rotation for the position of Council President Pro Tem for the last three months of 2017.
