AP Diaz most recently served as the Executive Officer for the Los Angeles Department of Recreation and Parks (RAP) and an Assistant General Manager overseeing all day-to-day operations of the Department, including financial services, capital projects, special operations, recreation, maintenance, HR and risk reductions matters, and governance and leadership matters. He also assisted the General Manager in all governance, legal, support and policy matters related to City's Park's Commission, the City Council, the City Attorney's Office, the Mayor's Office, and the LA Park Foundation. Prior to his roles as Executive Officer and Assistant General Manager, he served as General Counsel for LA's Park's Department. He notably worked on the transformation, restoration, and management model for the historic Greek Theatre which opened in 1930 and remains of the country's most recognized outdoor entertainment venues.

Since being announced as Interim Superintendent last September, my office has consulted with stakeholders regarding their perspective on AP Diaz's potential nomination, including representatives from the Board of Parks Commissioners, the University of Washington Botanic Gardens, the Seattle Parks Foundation, Sound Generations, the YMCA, the Seattle Aquarium, the Woodland Park Zoo, the Associated Recreation Council, and several staff members at the Parks & Recreation Department. Those stakeholders report that AP is a relatable, caring visionary who brings boundless energy and enthusiasm to his work. He cares about centering equity at SPR, looking to prioritize access for those furthest from opportunity and partnering with community organizations to advance those goals. Review of AP Diaz's

Seattle Parks and Recreation (SPR) manages a 6,441-acre park system of over 489 parks and extensive natural areas in Seattle, providing welcoming and safe opportunities to play and learn. SPR provides athletic fields, tennis courts, play areas, specialty gardens, and more than 25 miles of boulevards and 120 miles of trails. The system comprises about 12% of the city's land area. SPR also manages many facilities, including 25 community centers, eight indoor swimming pools, two outdoor (summer) swimming pools, three environmental education centers, two small craft centers, four golf courses, an outdoor stadium, and much more.

This week, the City Council, acting as the Parks District Board, approved a second cycle of funding advancing <u>a budget</u> focused on essential maintenance and restoration, reestablishing the Park Ranger program, and investments in equity, climate resilience, youth mentorship, and more.
