



Non-State Licensed Cannabis-Related Business Licenses Issued After Jan. 1, 2013

What This List Is:

- ◇ Preliminary. This is a first look at all non-state licensed cannabis businesses that have received a business license from the City of Seattle since 2013.
- ◇
- ◇ Inclusive. All types of non-state licensed cannabis businesses are listed including storefronts, processors, delivery services and vape lounges.

What This List Is NOT:

- ◇ Final. Many businesses on this list may be able to continue to operate without a Title VI business license until July 2016, if they prove they were in operation prior to 1/1/13 (see below), follow enforcement guidelines and remain eligible for a LCB marijuana retail license.
- ◇ This list is not an attempt to demonize or disparage any business listed by the City of Seattle. This list does not take into consideration beyond anything but when a business license was issued. The City is trying to address the uncontrolled growth of this industry and will approach each business with respect as enforcement efforts begin.

EXAMPLES OF A BUSINESS IN OPERATION PRIOR TO 1/1/13

- ◇ If the current operators are successors in interest of a cannabis-related business that was in existence prior to 1/1/13.
- ◇ If the business license was issued under a new trade name/legal entity to a cannabis-related business that was in existence prior to 1/1/13.

NEXT STEPS

- ◇ Prior to any large-scale enforcement action, the City Council needs to vote on the legislative proposals transmitted by Mayor Murray. However, the Departments of Planning and Development (DPD) and Finance and Administrative Services (FAS) will continue to investigate complaints about any business that they receive from the public.
- ◇ After enactment of the Mayor's proposals, FAS and DPD will send letters to business owners and their landlords that will inform them of the next steps in the process, including how to submit documentation if the business believes it qualifies for continuing to operate without a Title VI license between now and the July 2016 deadline.
- ◇ If a business is able to show that they established their operations before January 2013, that business will be able to continue operations, pending their adherence to the proposed Enforcement Resolution, without a Title VI license until July 2016. All medical cannabis establishments will have to apply for and obtain an LCB retail license by July 2016. No cannabis businesses will be able to operate in Seattle without a Title VI license after July 2016.
- ◇ If a business is unable to show that they established operations before 1/1/13, FAS will inform the owners how long they have to close their operation. If a business does not close by the date set by FAS, then civil penalties may be assessed. If a business continues to operate after civil penalties have been issued, criminal charges may be considered.
