



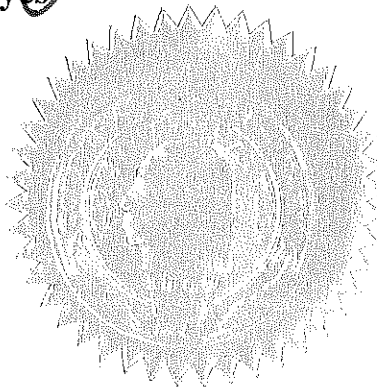

I am pleased to notify you that Mayor Ed Murray and I have appointed Patty Hayes as the Director of the Seattle – King County Department of Public Health, effective June 5, 2015. Additionally, I am transmitting a motion for Council's consideration to approve Ms. Hayes' appointment. A confirmation packet will be transmitted to the Council shortly. Hayes will appoint Dr. Jeff Duchin as the department's Health Officer, effective immediately. Duchin has served as Interim Health Officer since January 2015, and is also Chief of the Communicable Disease Epidemiology and Immunization Section.

The Director of Public Health – Seattle & King County is responsible for the managerial oversight of a complex metropolitan public health department and sets the strategic direction for the department through collaborative business planning process in both the City of Seattle and King County. In addition, the director leads resource development strategies, including federal and state grant development, Medicaid and other insurance vehicles, and private foundation grants.

The director is jointly appointed by the King County Executive and the Mayor of the City of Seattle in collaboration with the King County Board of Health. He or she will be confirmed by the King County Council and the Seattle City Council, and will be responsible to the Board of Health. The director is responsible for a department of approximately 1,500 employees located in multiple sites and complex service delivery partnerships with community health centers, fire departments, area hospitals, criminal justice, and a broad range of community-based organizations.

ABOUT THE DEPARTMENT:

Public Health – Seattle & King County (PHSKC) exists to achieve and sustain healthy people and healthy communities throughout King County by working to protect and improve the health and well-being of all people in King County as measured by increasing the number of healthy years that people live and eliminating health disparities. PHSKC is the one of the largest metropolitan health departments in the United States with 1500 employees, 40 sites, and a budget of \$318 million. The department serves over 1.9 million residents of King County including the City of Seattle, incorporated suburban cities, and unincorporated areas of the county.
