## NOTICE OF CITY COUNCIL PUBLIC HEARING ON A MORATORIUM ON THE FILING, ACCEPTANCE AND/OR APPROVAL OF PERMITS FOR DEVELOPMENT IN AREAS CURRENTLY DEVELOPED AS A MOBILE HOME PARK

On February 6, 2019, the City Council, on an emergency basis, passed Ordinance 125764, which established (1) a temporary moratorium on accepting and/or approving permits for development on sites currently developed as mobile home parks and (2) a work program for considering permanent regulations related to redevelopment of current mobile home park sites.

There will be additional opportunities for public comment and a public hearing in the future before any permanent development regulations are established by the Council.
