# THE UNIVERSITY OF WASHINGTON – THE CITY OF SEATTLE MEMORANDUM OF AGREEMENT

## FOR ABANDONMENT OF SHARED FIBER-CABLE TO TEMPORARY CAMPUS AT SW 228<sup>TH</sup> STREET IN BOTHELL

THIS MEMORANDUM OF AGREEMENT ("Agreement") is made by and between The University of Washington ("UW") and The City of Seattle, by and through its City Light Department ("Seattle"), both Washington corporations, individually, as a party ("Party") or, jointly, as parties ("Parties") to this agreement.

#### **RECITALS:**

A 144-strand of shared fiber cable was installed in 1998-1999 and co-owned by UW (96 strands) and Seattle (48 strands). The section of shared fiber cable applicable to this Agreement starts from the intersection of "NE 145th St. & 37th Ave NE, Seattle" to the intersection of "228th St. SE & 29th Dr. SE, Bothell" as shown in Exhibit A. This section of shared fiber cable consists of the fiber and associated physical plant, such as sleeve, conduit, handholds, and splice boxes mux. This section of shared fiber cable was found to be degraded and in need of replacement in the near future. UW has decided to abandon all interests in this section of shared fiber cable in lieu of replacement since UW no longer has a need for this section of shared fiber cable.

This memorandum of agreement is to reflect UW's decision to abandon all interests in the existing shared fiber cable and physical plant to Seattle, and Seattle's intent on replacing the degraded cable at its expense.

#### AGREEMENT:

#### 1. SHARED FIBER CABLE REPLACEMENT

UW acknowledges that it received notice from Seattle of Seattle's intention to replace the above described shared fiber cable with new fiber cable and that replacement has been completed.

#### 2. FIBER OWNERSHIP

UW acknowledges that from the date of this agreement, it will have no ownership interest in the existing shared fiber cable, nor will it have any interest in the newly replaced fiber cable, physical plant, conduits, and handholes. As such, UW will not have any obligation to share in the cost of replacement and maintenance of the same.


