I write to thank you most sincerely for your work to develop the proposal contained in HSD-035-A-001-2023), and to offer the Coalition on Homelessness' strong support of this reasonable and

regional approach to assisting people without homes in our city, and working towards a clearer and more useful division of roles and services between and among City employees; KCRHA as the agency responsible for crisis response services and systems;; and contracted skilled service providers working through KCRHA.

I appreciate that in constructing this amendment you've taken the time to listen deeply and think carefully in conversations with us, with staff for the KCRHA and from Mayor Harrell's office, and with agency members of our Coalition who do the essential and difficult work to support thousands of people without homes or shelter in Seattle every day and night, and to house, shelter, and help thousands more. I want to acknowledge that there are important additional elements of this work that will still need to be worked through, but it is clear to the Coalition that the approach outlined allows the city of Seattle to perform its roles related to cleaning and providing sanitation and other services, and the people who are trained to provide multi-disciplinary problem solving and human services to do their work, with collaboration and coordination to ensure the best possible outcomes for people who are unsheltered, and other community members.

We're willing and able partners as the outlined work is implemented. Thank you for continuing to take up the work of creating policies that support people in this city with true public health, public safety and sanitation services, and real responses to the crisis of homelessness in our community.
