It is well established that compost production and use provide significant environmental benefits to our soil and food; and 12 13 WHEREAS, RCW 43.19A.150 became effective on June 9, 2022 and requires cities and 14 counties in Washington with a population greater than 25,000 residents or in which 15 organic material collection services are provided to adopt a compost procurement 16 ordinance by January 1, 2023; NOW, THEREFORE, 17 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS: 18 Section 1. A new Subchapter IV is added to Chapter 20.60 of the Seattle Municipal Code 19 as follows: 20 **Subchapter IV Compost Procurement** 21 **20.60.300 Definitions** 22 "Compost products" means soil amendments, mulch, or other landscaping material derived from "composted material" as defined in WAC 173-350-100. 23 24 20.60.310 Procurement plan 25 When planning government-funded projects or soliciting and reviewing bids for such projects, 26 The City of Seattle shall consider whether compost products can be utilized in the project and

1	shall plan for the purchase of compost products for use in public projects in which compost is an
2	appropriate material. If compost products can be utilized, the City shall use, or require the
3	contractor to use, compost products unless an exception under RCW 43.19A.120 applies.
4	Pursuant to RCW 43.19A.130, the City will strive to purchase an amount of compost products
5	that is equal to or greater than 50 percent of the amount of organic materials delivered to
6	compost processor(s).
7	20.60.320 Purchasing
8	When purchasing compost products, the City shall prioritize purchasing compost products from
9	companies producing compost from composted materials sourced from within Seattle, are
10	certified by a nationally recognized organization, such as the United States Composting Council,
11	and produce compost products that are derived from municipal solid waste compost programs
12	while meeting quality standards adopted by the Washington State Department of Transportation
13	or adopted by rule by the Department of Ecology.
14	20.60.330 Planning
15	The City shall plan for compost use in the following categories:
16	A. Landscaping projects;
17	B. Construction and postconstruction soil amendments;
18	C. Applications to prevent erosion, filter stormwater runoff, promote vegetative growth,
19	or improve the stability and longevity of roadways; and
20	D. Low-impact development of green infrastructure to filter pollutants to keep water
21	onsite or both.

The total tons of organic material diverted each year; 9 B. The estimated volume and cost of composted material purchased each year; and 10 C. The source(s) of the compost products purchased.
