In recent years, about half of the auditor staff has retired and the office is seeking to hire experienced candidates for jobs requiring significant training and skills to comply with U.S. Comptroller General's Government Auditing Standards. Without this funding, the office anticipates hiring a candidate with limited or no performance audit experience or leaving the vacant position open for an extended period, resulting in the office conducting fewer performance audits and special projects in 2024 and in future years.
