- Why do we have a Stormwater Code?
 - Protect life, property, surface waters from harm
 - Meet requirements of state and federal law
 - Required under the federal Clean Water Act / National Pollutant Discharge Elimination System (NPDES) Municipal Stormwater Permit



- Who administers?
 - DPD (private property development)
 - SPU (right-of-way development & other provisions)
 - SDOT responsible for construction erosion control enforcement for right-of-way permits
- Who is affected by the code?
 - Private developers and city projects
 - Businesses
 - Residents

Ecology Review Status

- August 2012
 - Ecology re-issued NPDES Stormwater Permit (effective 2013 – 2018) & Ecology Manual
- April 2014
 - Seattle submitted draft Stormwater Code & Directors' Rule (Stormwater Manual) to Ecology
- December 2014
 - Ecology re-issued NPDES Permit & Ecology Manual
- February 2015
 - Ecology provided written comments to Seattle
- February 2015 Present
 - Seattle addressing Ecology's comments
- Seattle & Ecology discussions




Revised Implementation

- Originally planned to have all Seattle Code & Stormwater Manual revisions effective June 30, 2015 per NPDES Stormwater Permit
- Allowed effective date extended until January 2016 because Ecology was delayed
- To have some changes effective around the original effective date, two legislative process will be used:
 - ► 2015 Stormwater Code Revision
 - ➤ 2016 Stormwater Code & Manual Update

Next SPUN Meeting 4/14/15

- 2015 Stormwater Code Revisions:
 - 1. SPU Capital Improvement Drinking Water Utility Projects exemption
 - 2. Flow Control Requirement changes in some Public Combined Sewer Areas
 - 3. Water Quality Treatment threshold changes for Roadway Projects



Summer 2015

- 2016 Stormwater Code & Manual Update:
 - Additional Code Changes
 - Mainly focused on Ecology's requirements
 - Revised Stormwater Manual (aka Directors' Rule)
 - Simplified & condensed text
 - New volume "Minimum Requirements"
 - Reorganized
 - Revised based on Ecology requirements and lessons learned



Project Outreach

- ✓ **Spring 2013:** Outreach to Frequent Users
- ✓ Summer 2013 Winter 2014: Public Outreach
- ✓ **Spring 2014:** Initial drafts available for public comment

Spring 2015: 2015 Stormwater Code Revision legislative process & formal public review (scheduled to take effect May 2015)

Summer 2015: 2016 Stormwater Code & Manual Update legislative process & formal public review

January 2016: 2016 Stormwater Code and related Directors' Rules are scheduled to take effect

- 2016 Stormwater Code & Manual Update to SPUN Committee – July 2015
