#### **Legislation Title:**

A RESOLUTION expressing support by The City of Seattle for all workers, including musicians, to exercise their right to negotiate fair contracts, to establish equitable business relationships, and to benefit from enforceable contract standards.

#### **Summary of the Legislation:**

This Resolution affirms the City's support for musicians' rights to negotiate fair contracts, establish equitable business relationships, and abide by enforceable standards.

# **Background:**

Fair Trade Music Seattle, with the support of the Musicians Association of Seattle and the American Federation of Musicians Local 76-493, is uniting musicians to promote the value of fair working conditions. The City is committed to supporting Seattle's music industry, as evidenced by its City of Music initiative, which notes that in 2008, music created 20,193 jobs in the region, with \$2.2 billion in sales and \$840 million in earnings, and generated \$148 million in tax revenues in King County. This Resolution compliments the City's support of Seattle's music industry.
