

Experience

1992-2003 Executive Director, Puget Sound Regional Council

The Puget Sound Regional Council is designated by the federal government and the state as the area's Metropolitan Planning Organization and Regional Transportation Planning Organization. The Regional Council was formed on October 1, 1991, by local governments in the central Puget Sound region as a forum for making key decision on regional growth and transportation issues. The Council includes King, Kitsap, Pierce and Snohomish counties and cities.

In June 1997, Mary McCumber was selected as the Public Official of the Year by the Municipal League of King County and in 2003 was awarded the Larry Dahms Life Time Achievement Award by the Association of Metropolitan Planning Organizations.

1991 Research Consultant, Institute for Public Policy and Management, University of Washington

Responsible for developing a strategic plan for the University of Washington to assist national, regional and local growth management efforts.

1989-1990 Executive Director, Washington State Growth Strategies Commission

Executive Director of a 17-member commission appointed by Governor Booth Gardner. The Growth Strategies Commission was charged with developing recommendations to address the complex issues of growth facing Washington State. Based on the Commission's recommendations, landmark growth management legislation was enacted by the 1990 and 1992 sessions of the Legislature.

1986-1989 Director, Auburn Department of Planning and Community Development

Responsible for physical planning (long-range and development project review) and social service planning for a rapidly growing King County city. Implemented a new comprehensive plan for the city, which revised the city's zoning, downtown revitalization efforts, environmental protection and urban design planning. In addition, the city's library and airport were under the supervision of the Director.

1981-1985 Chief of Growth Management Section, King County Department of Planning and Community Development

Responsible for comprehensive planning and growth monitoring. Managed the development of the 1985 King County Comprehensive Plan and the overall implementation program (2000 square miles; 500,000 unincorporated population). The growth monitoring function encompassed the management of the county's computerized land development information system and initiation of Annual Growth Reports. The Annual Growth Report received the Outstanding Planning Award from the American Planning Association and two State awards.

1978-1981 Planner in Community Planning Section, King County Department of Planning and Community Development

Project leader for the preparation of the Newcastle Community Plan. Developed a land use and transportation plan with a citizen advisory committee for a 40-square mile area that balanced accommodating growth, developing a regional park, and preserving rural and environmentally sensitive lands. Also served as the project leader for a revision to the Federal Way Community Plan, with particular emphasis on land use and sewer service issues.

1976-1977 Planner, Lorig and Associates, Seattle, Washington

Part of a consultant team studying and developing recommendations on the zoning code for the City of Seattle.

Historic preservation. Eighteen years (1980-1987; 2003-2014) on Historic Seattle Preservation and Development Authority Council (four years as chair); seven years (1987-1993) on Seattle Landmarks Preservation Board (1989 and 1990 chair); and two years on the Washington State Capital Campus Design Advisory Committee (2000-2002).

Founding member of 1000 Friends of Washington, a non-profit organization dedicated to achieving effective growth management in Washington State (1991-1992). Returned to 1000 Friends' Board (now called Futurewise) in 2004, serving as president for three years.

The Historic Seattle PDA is an organization created in 1975 in accordance with SMC 3.110. The PDA Council has twelve members, four of whom are appointed by the Seattle Mayor, four of whom are appointed by existing PDA Council members, and four of whom are appointed by the PDA's constituency. All appointments to the PDA Council are confirmed by the Seattle City Council.

Ms. McCumber is a long-time supporter of Historic Seattle, having served eighteen years on the Council (1980 – 1987 & 2003-present). This includes four years as Council chair.
