July 24, 2014 PIKE PLACE MARKET CONSTITUENCY EXECUTIVE COMMITTEE MEETING

Members Present: Pearl Varon, Gloria Skouge, Betty Halfon, Joan Paulson, Sharon Mukai, and Chris Scott.

Chris Scott chaired the meeting as the newly elected Vice Chair. The meeting was called to order at 6:14 p.m. He welcomed Pearl Varon to the Board. Following was a discussion of the PDA Council meeting that had occurred before our meeting. Chris began by stating that the meeting was hard to hear. Betty said that several people were concerned that the PC1-N area might turn into an area of just Craftspeople. She said it should be farm and craft space. This will be discussed at the Marketing meeting. Betty also said that it must be clear that the PC1-N development is a good fit to the original Market.

Next was a discussion of topics for the August Agenda for the General Assembly meeting.

- 1) Ratification of the July election.
- 2) Move the discussion of the Hildt-Licata Agreement to September.
- 3) Introduce the group formed as the Stakeholders as concerns the PC1-N development. Invite them to come to a Constituency Meeting.
- 4) Chris Scott has an idea to partner with the Cornish School Academy. What is the goal? Betty asked what is our relationship to be. To bring art to the Market. Other institutes we could talk to would be Fare Start, the Art Institute and Seattle Central CC.

Officers Concerns: Betty said we need a list of the next meetings and a better communications process for meeting times.
