1 **CITY OF SEATTLE** ORDINANCE 124780 2 COUNCIL BILL 118380 3 4 AN ORDINANCE relating to the Seattle Public Utilities' Arbor Heights Fire Flow 5 Improvements project; accepting an easement for water and sewer purposes over, under, through, across, along and upon property commonly known as 3707 SW 105th Street, 6 King County Assessor Parcel number 022303-9302; and ratifying and confirming certain 7 8 prior acts. 9 10 WHEREAS, Seattle Public Utilities' Arbor Heights Fire Flow Improvements Project replaced a 2-inch water main with an 8-inch water main to increase and assure water flow for fire 11 12 suppression; and 13 WHEREAS, the City of Seattle subsequently discovered it has no property rights where part of the water main crosses property commonly known as 3707 SW 105<sup>th</sup> Street, King County 14 15 Assessor Parcel number 022303-9302; and 16 WHEREAS, the City of Seattle required a recorded easement across said parcel for water and 17 sewer purposes prior to construction; and 18 WHEREAS, owner of said parcel, Jeanne A. Hedington, donated and granted the needed 19 easement; and 20 WHEREAS, to keep the project on schedule it was necessary to record the easement document 21 prior to having the easement accepted by a City of Seattle ordinance; NOW, 22 THEREFORE, 23 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS: 24 Section 1. The City of Seattle hereby accepts the easement attached as Attachment 1 25 hereto and recorded under King County recording number 20120627001488, granted to the City

THIS EASEMENT made this day by and between Jeanne A. Hedington, hereinafter called "Grantor", and The City of Seattle, a municipal corporation of the State of Washington (acting through its agency, Seattle Public Utilities), hereinafter called "The City"; WITNESSETH;

That the Grantor, hereby donates, conveys and grants an Easement to The City, its successors and assigns, for the purposes herein described, over, under, through, across, along and upon property located in King County, Washington, described as follows:

The North 30 feet of the West 65 feet of the East 120.46 feet of the South one-half (1/2) of the Northwest one-quarter (1/4) of the Northeast one-quarter (1/4) of the Southeast one-quarter (1/4) of Section Two (2), Township Twenty-Three (23), North, Range Three East, W. M.; except the South 184 feet thereof, situated in the County of King, State of Washington.

The City or its agents at such times as may be necessary, shall have the right, privilege and authority without prior institution of any suit or proceeding at law, to enter upon said easement area to install, construct, reconstruct, erect, alter, improve, repair, operate, retire, and maintain water and sewer mains, and any appurtenances to either main, including but not limited to connecting water and sewer service pipes, hydrants and meters.

The Grantor hereby agrees to allow the existing 2- inch water main to be retired in place.

This Easement in no way is intended to limit any other rights the Grantor legally has from using the property for any other purpose that does not conflict with the rights herein granted.

The Grantor hereby represents and warrants to the City that she is the sole owner of the Easement Area and has the power and authority to convey the rights herein granted to the City.

This Easement and each of the terms, provisions, conditions and covenant herein, shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, successor and assigns.
