1. BILL SUMMARY

Legislation Title: AN ORDINANCE related to the Seattle Preschool Program; approving a Comprehensive Evaluation Strategy as required by Resolution 31527.

Summary and background of the Legislation:

In November 2014, Seattle voters passed a \$58.3 million levy lid lift to provide high-quality preschools for Seattle families. This proposed legislation approves a Seattle Preschool Program Comprehensive Evaluation Strategy as required by Section 3 of Resolution 31527. The Comprehensive Evaluation Strategy for the Seattle Preschool Program, attached to this Council Bill, includes a detailed plan for ensuring the Seattle Preschool Program engages in continuous quality improvement both in relation to program infrastructure and processes and in relation to program impacts on children's kindergarten readiness.

Third Sector Intelligence Inc., a team of independent evaluation experts, is preparing two reports related to this legislation. One is entitled "Seattle Preschool Program Recommended Comprehensive Evaluation Strategy," and the other is entitled "A Technical Report for the City of Seattle: A review of the evidence on preschool programs and a comparison of selected state and city programs." The Technical Report provides a review of the evidence on preschool programs and a comparison of selected state and city programs and a comparison of selected state and city programs.
