Lara has 18 years of experience supporting local organizations, mostly in Latin America and the Caribbean and southeastern Europe, to design, deliver and resource community development programs in sectors including: public health, agricultural enterprise, microfinance, and citizen participation. She worked for Catholic Relief Services for 13 years, 8 of which were spent living overseas (Nicaragua, Bulgaria, Macedonia, and Albania).									
She is most proud of: 1) launching a micro finance program in Bulgaria from zero in 1999, which is now a registered financial institution, and 2) supporting 600 Nicaraguan smallholder coffee farmer families move from subsistence to fair tradecertified and selling high quality product through their own cooperative in 2003; and 3) supporting multiple organizations design sustainable health services programs that now collectively serve over 200,000 people.									
From 2001-2006, Lara served on the Board of NicaSalud, a Nicaraguan network of local and international organizations implementing community-based health programs, while serving as CRS' Country Director in Nicaragua.									
Lara is now an independent consultant, seeking to get more involved in local development concerns in the greater Seattle area. She earned an MBA with a concentration in Non-profit Management and an MA in International Relations from Yale University, and a BA in International Relations from Grinnell College.
