1. BILL SUMMARY

Legislation Title:

AN ORDINANCE relating to Seattle Public Utilities; authorizing the Director of Seattle Public Utilities to execute amendments to wheeling agreements between The City of Seattle and North City Water District and between The City of Seattle and Olympic View Water and Sewer District.

Summary and background of the Legislation: This legislation would authorize the director of Seattle Public Utilities (SPU) to execute amended agreements between Seattle and two of its wholesale water customers, North City Water District and Olympic View Water and Sewer District.

The two wholesale customers receive Seattle water via a subset of the Seattle regional water transmission system called the Northwest Subregional system. The system distributes water to retail customers in the City of Shoreline and conveys water to North City Water District and Olympic View Water and Sewer District. North City and Olympic View each have an agreement for the transmission, or "wheeling", of that water.

In accordance with the wheeling agreements, Seattle can review and adjust rates periodically and did so earlier this year to more accurately distribute system costs. The rate increase prompted North City and Olympic View to express a desire for more rate predictability and stability. Seattle wanted to be responsive to customer concerns and negotiated amendments to North City's and Olympic View's wheeling agreements to meet their interests while maintaining Seattle's flexibility to operate the Northwest Subregional system and be compensated for system costs. Under the proposed amendments: 1) Seattle will review and adjust wheeling rates in the future using the same methodology that was used most recently for this purpose *unless Seattle changes the system infrastructure or its uses;* and 2) the two utilities will have an opportunity for input into decisions about capital projects that could influence their wheeling rate.
