This budget action would add position authority for 25 police officer patrol positions to the Seattle Police Department (SPD).

As part of adopting the 2016 Endorsed Budget, the Council approved Budget Action 89-2-A-3, which set aside \$2,787,745 GSF for hiring 25 additional police officers in a Finance General reserve. The Council's intent was to review the results of an independent analysis of SPD staffing, and an implementation plan based on that analysis, before making this funding available to SPD. The independent analysis was funded by the Council in the 2014 Adopted Budget (Budget Action 97-1-A-1).

In March 2015, SPD hired Berkshire Advisors to carry out the staffing analysis. The 2016 Proposed Budget left the funding for the 25 additional officers in Finance General, with the assumption that the analysis would be available for Council review together with the budget. However, the consultants' initial findings are now scheduled to be available in late November 2015, after the Council adopts the 2016 budget.

This budget action would add position authority in SPD for the 25 officers, while holding the funding for the officers in Finance General until the Council reviews the SPD staffing analysis and plan. Providing the unfunded positions would allow SPD to continue the hiring of new officers to replace those leaving the department. In previous years, SPD has had several unfilled funded positions available at the end of the year to carry over into the following year. In 2015, SPD is on track to reach its hiring goal for the year, due in part to improvements in hiring procedures. As a result, SPD will not have any vacant officer positions at the end of December 2015.

The position authority for 25 police officer positions would allow the department to hire in anticipation of separations in the first half of 2016. If SPD delays the hiring process, it may affect the department's ability to achieve its officer hiring goal and could jeopardize its efforts to secure candidates who may have applications pending with other agencies.

Continuing to hold the funding for the 25 new officer positions in Finance General emphasizes the Council's high priority for completing the staffing analysis and plan.
