1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to the creation of a Title 6 business license; adding a new Chapter 6.208 to the Seattle Municipal Code; and amending Sections 5.30.030, 5.32.150, 5.55.230, 6.10.005, 6.20.050, 6.214.310, 6.250.030, 6.500.140, 7.04.645, 21.16.060, 21.16.080, and 22.214.060 of the Seattle Municipal Code.

Summary and background of the Legislation:

This legislation creates a new Title 6 business license that nearly all businesses engaging in business in the City will be required to obtain. It will be issued concurrently with the business license tax certificate that businesses currently obtain under SMC 5.55.030. There will be no separate fee for the new Title 6 license.

In addition, the legislation amends SMC ch. 5.55 to remove the regulatory provisions in that chapter that are not related to the tax code and then places those regulatory provisions in the newly created SMC ch. 6.208. This reorganization will facilitate the administration of the City's tax code under Title 5 and the City's regulation of businesses under Title 6. It will clearly separate the tax code provisions in Title 5 and the regulatory provisions in Title 6.
