1 CITY OF SEATTLE ORDINANCE 2 COUNCIL BILL 3 4 AN ORDINANCE relating to pet licensing; adjusting cat and dog license fees; and amending 5 6 Section 9.26.020 of the Seattle Municipal Code. 7 WHEREAS, license fees for dogs and cats were last increased in 2010 and 2011, respectively; 8 9 and 10 WHEREAS, a nominal increase in pet license fees will bolster the Seattle Animal Shelter's ability to provide the high levels of quality care the animals entrusted them so deserve; 11 12 and WHEREAS, a nominal increase in pet license fees will not exceed the costs incurred by the City 13 in providing services related to the Seattle Animal Shelter under the Seattle Municipal 14 Code; NOW, THEREFORE, 15 16 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS: Section 1. Effective January 1, 2016, Section 9.26.020 of the Seattle Municipal Code, 17 18 last amended by Ordinance 124039, is amended as follows: 19 9.26.020 Cat, dog or goat license fee – Renewal((-)) A.
