1. BILL SUMMARY

Legislation Title: AN ORDINANCE establishing the terms and conditions for members of the Labor Standards Advisory Commission; amending Section 3.14.934 of the Seattle Municipal Code; and ratifying and confirming certain prior acts.

Summary and background of the Legislation:

This legislation establishes the terms and conditions for members of the Labor Standards Advisory Commission established in 2014 by Ordinance 124643.

The Commission will be comprised of 15 members reflecting Seattle's workforce and businesses and include employees, employers and representatives from the community with a demonstrated concern and background in labor standards; who will recommend efforts to achieve workplace equity for women, communities of color, immigrants and refugees and other vulnerable workers and will report on an annual basis to the Mayor and City Council.

Ordinance 124643 established that seven members will be appointed by the Mayor and seven members will be appointed by the City Council with the 15th member appointed by the City Council with all members confirmed by the City Council, but omitted the term of appointment or other conditions of appointment. This ordinance establishes two year terms for Commission members that will be staggered to provide continuity to the Commission. Commission member terms may serve for two terms. The appointing authority may remove any member who is absent from two or more consecutive meetings without good cause.
