

# Major Litigation

Staff Management v. Jimenez, 839 N.W. 640 (lowa 2013), As amicus curiae in Iowa Supreme Court ruling that undocumented immigrant worker had right to state workers' compensation benefits.

Salas v. Hi-Tech Erectors, 168 Wash. 2d 664 (2010), As amicus curiae in ruling holding immigration status inadmissible in tort litigation.

Bollinger Shipyards, Inc. v. Director, Office of Worker's Compensation Programs, 604 F.3d 864 (5th Cir. 2010), As amicus curiae in ruling holding immigration status irrelevant to federal workers' compensation claim.

Cagnoli v. Tandem Staffing, 914 So.2d 950 (Fla. 2005), As amicus curiae. State may not require injured workers to present a social security number as a pre-condition for application for workers' compensation benefits.

Design Kitchen and Bath v. Lagos, 882 A.2d 817, (MD. Ct. Apps., 2005), As amicus curiae. Injured undocumented workers remain entitled to state workers' compensation benefits after Hoffman Plastics Compounds.

Rivera v. Nibco, Inc., 364 F.3d 1057 (9th Cir. 2004), principal author of amicus curiae brief. Ninth Circuit upheld post-Hoffman protective order barring discovery of immigration status of twenty-three employment discrimination plaintiffs.

Juridical Condition and Rights of the Undocumented Migrants, OC-18, Interamerican Court of Human Rights (2003), Interamerican Court found that international migrant workers are entitled, under international human rights principles, to equal protection of labor and employment laws with nationals of receiving country. Co-authored amicus brief, and presented oral argument on behalf of fifty amici. Opinion available at http://www.corteidh.or.cr/serie\_a\_ing/serie\_a\_18\_ing.doc.

Rubalcaba v. Nagaki Farms, Inc., No. 48217 (Oregon, April 11, 2002) represented amici curiae in case establishing that truck driver was "worker" covered under Oregon workers' compensation law.

Hoffman Plastic Compounds, Inc., v. NLRB, 152 L.Ed. 2d 271, 122 S.Ct. 1275, 1283-84 (2002) principal author of *amicus curiae* brief. US Supreme Court ruled, 5-4 against immigrant worker, holding that undocumented worker not entitled to back pay when employer fires him in violation of the National Labor Relations Act.

Torres-Lopez v. May, 111 F.3d 633 (9th Cir. 1997) represented farm worker amici curiae in case establishing that farm and its farm labor contractor were jointly liable to workers for violation of Agricultural Worker Protection Act and Fair Labor Standards Act.

Rodriguez v. Carlson, 166 FRD 465 (ED Wash. 1996) and 943 F. Supp. 1263 (ED Wash. 1996) Class action successful in holding agricultural employer and its CEO liable for .providing substandard housing to their employees, including that workers lived in cardboard boxes, cooked over open fires, and were exposed to snakes and other vermin.

Peters v. U.S., 853 F. 2d 692 (9th Cir. 1987) Ninth Circuit reversed district court's ruling, denied enforcement of INS' third party subpoena directed at a labor camp and intended to identify undocumented workers living in the camp.

Guerra v. Sutton, 783 F .2d 1371 (9th Cir. 1986) Ninth Circuit reversed district court's ruling, held INS liable for Fourth Amendment violations arising out of a pre-dawn warrantless raid on clients' homes.
