

### Summary

More than twenty years of professional experience as a planner primarily focused on analyzing the feasibility and environmental effects of transportation infrastructure projects in the Puget Sound Region and across the United States, including light rail transit, multi-modal facilities, heavy rail, tunnels, bridges (vehicular and pedestrian), ferry systems and highways. Skills include project development and coordination, building community consensus, coordinating collaborative efforts on multi-disciplinary teams, feasibility and analysis of alternatives, preparation of environmental documentation and permitting, managing large teams and supervising staff. Additional planning experience includes land use, disaster recovery, and fisheries projects.

More recently, Marj has invested in two small businesses in Seattle. She is a founding member and co-owner of Terra Plata, a Capital Hill Restaurant. She also is co-owner of Skelly and the Bean, a restaurant formerly on Capital Hill and in search of a new location. Both restaurants support local farmers, purveyors and the Community Supported Agriculture (CSA) program.
