- Manage a caseload of 40+ youth currently enrolled at Interagency Academy through the Seattle Public Schools. Interagency
 Academy is a network of small, alternative high schools spread across Seattle designed to support students wherecomprehensive
 schools may not meet. Case load includes parenting and pregnant youth, homeless youth, youth with drug/alcohol use or involved
 with drug-court program, youth with mental health, IEP students, immigrants/refugees, gang and criminally involved youth.
- Provide resource brokering, social work advocacy and on-going case management while youth are enrolled in program so they can
 successfully meet their educational and employment goals to become self-sufficient. Work with youth one-on-one to establish
 Individualized Service Plans to meet Basic Skills and Work-Readiness Skills goal each quarter that align with their personal,
 educational and professional goals that lead to a long-term pathway in employment or post-secondary education.
- Provide crisis intervention for youth facing emotional, physical and social needs; minimize and de-escalate potential psychological trauma to increase stabilization and encourage healthy coping mechanisms.
- Coordinate and partner with school teachers, staff, community members and families through educational site and home visits to broaden youth's assets and support systems to provide stronger accountability while leveraging resources for youth. Act as a point of contact or liaison on behalf of the youth during coordinated care with other treatment and social service providers.
- Other Achievements:
 - Workgroup for Seattle Race and Social Justice Initiative- A citywide effort to end institutionalized racism and race-based disparities in City government. The Initiative's long term goal is to change the underlying system that creates race-based disparities in our community and to achieve racial equity. As part of the work group, my responsibility is to ensure that Human Services Department's best practices, contracts to the community, deliverable outcomes and services to the community align within the RSJI framework. In addition, I analyzed population data to identify racial disparities and created racial disparity statements that are now the foundation of our division's decision making process. Our division's budget is approximately \$20 million and we administer contacts and provide direct services for youth and young adults. My participation and advocacy is influencing what could be a typical bureaucratic process to one that will result in critical policy making to meet the greatest needs in our community.

Coordinator for Health Career Youth Project- Collaborated with Seattle Central College, Seattle Vocational Institute and the Workforce Development Council to develop health career training program for youth; served as project lead and point of contact to recruit youth ages 16-18 living in Seattle who are underrepresented, including bilingual youth of color to make education and employment in health care careers more accessible. A model that began in 2004, I continued to strengthen and build capacity by establishing a direct pipeline for youth to be hired by health care agencies; and implemented stronger infrastructure by integrating marketing tools and information sessions out in school and community centers. In 2015, after collecting surveys by youth and analyzing trends in the health career field, I developed 4 new health care training programs that are in demand: dental assistant, medical assistant, phlebotomy, and medical office professional. 95% of youth recruited have gone on to paid work experience, high school completion, additional education and/or employment in the health care field.

City of Seattle Human Services Dept. -Youth and Family Empowerment Division Planning and Development Specialist (Out-of-Class)

- On November 2nd, 2015, the Mayor of the City of Seattle called for a State of Emergency on Homelessness (SOE). Under this State of Emergency, a Civil Ordinance was also called to address homeless school children in Seattle Public Schools. I was selected to take an out-of-class position to represent the Human Services Department to do strategic planning on how to distribute SOE funding to the Seattle Public Schools and ensure that the homeless children and youth would receive equitable and holisticservices.
- Worked closely with the McKinney Vento Program to identify current internal processes of working with homeless children and youth
 at Seattle Public Schools; gathered information to analyze gaps in services and make recommendations to streamline processes
 between the program and each school. This allowed me to act as a liaison with the school district on data translation and how the
 City can support in streamlining services especially to address the high proportion of youth of color being impacted.
- Researched the top three elementary, middle and high school with the most homeless student population; outreached to each school to discuss unique challenges the staff face working with homeless children; learn about the school's current process of identifying a homeless family and the services that are not in place to holistically care for a child; discussed capacity for prevention and intervention strategies at the school; discussed existing referral services and areas that need a sustainable pipeline of resources.
- Based on school outreaches, interpreted both qualitative and quantitative data to best inform how to allocate \$65,000 funding to Seattle Public Schools and other partnered agencies to strengthen and build capacity.
- Prepared Logic Model: Outlined projected Inputs for investments with a breakdown of staffing and financial resources; synthesized
 the activities for the inputted investments and outlined Outputs and Outcomes through a short-medium term intervention and longterm prevention plan to address homelessness for Seattle Public School children and families. Provided overview and limitations of
 efforts
- Interpreted Seattle Public school McKinney Vento Program's current enrollment numbers and disaggregated data based on a child's homelessness status: unsheltered, sheltered, doubled-up, hotel/motel in order to better communicate intervention strategies and support the Human Services Department in prioritizing intervention efforts for the unsheltered children and families.
- Worked with Seattle Parks and Recreation, Rapid-Rehousing agencies and Diversion Assistant programs to increase capacity during
 the winter holidays months; distributed \$8000 to the McKinney Program to be used in the month of December and provided tracking
 tool to staff in order to extract information and provide thoughtful analysis to ensure funding was distributed equitably amongst
 youth and families.

- As a fellow, I am given the opportunity to utilize the knowledge and skills attained through the Institute by developing an advocacy
 project that is relevant and responsive to a distinct service provision and program offering for individual youth and families in
 Seattle.
- My advocacy project:

- Create a community asset mapping of individual allies and organizations supporting the efforts of juvenile justice reform in Seattle; analyze current projects and connect allies together to strengthen capacity, create streamlined coordination of shared resources so duplication of efforts can be reduced.
- Hold Seattle City Councilmembers accountable for implementing zero youth incarceration by advocating for the voter approved \$210 million King County Youth and Family Justice Center to be re-examined and instead use funding towards prevention and alternatives to detention.
- Research current Seattle shelter capacity for unaccompanied minors and homeless youth and through review of data, recommend that housing options must increase in order to prevent youth from engaging in criminal behavior activities that leads to incarceration; research on Seattle Public School's truancy policy and how best to reform the current Becca Bill to prevent a student from being detained to decrease status offenses.
