## 1. BILL SUMMARY

**Legislation Title:** A RESOLUTION establishing the shared city and community goals and strategies of the Equity and Environment Agenda as City policy and a critical aspect and foundation for all environment and sustainability work in Seattle.

Summary and background of the Legislation: Seattle is widely known for its environmental leadership. From recycling to climate protection, we've consistently modeled best practices that are recognized around the world. However, in Seattle we face many of the same challenges as the broader US environmental movement: it is primarily white, upper-income communities who shape and benefit from environmental policies, approaches and outcomes. And while people of color, immigrants and refugees, people with low incomes and limited-English language proficient individuals care about and are working on environmental issues, they are often doing so outside of government and mainstream processes due to historic and ongoing institutional practices and policies.

For Seattle to continue to lead in environmental excellence it is important to understand who is and is not benefiting from our environmental progress. We need to engage those most impacted by environmental injustices – people of color, immigrants and refugees, people with low incomes and limited-English language proficient individuals – in meaningful ways to shape the environmental agenda and solutions. To accomplish this, Mayor Murray launched the Equity and Environment initiative in 2015 to put equity and environmental justice front and center as Seattle continues to lead with environmental excellence. The Initiative aims to advance the following three goals:

- 1. All people and communities benefit from Seattle's environmental progress.
- 2. Communities most impacted by environmental injustice are foremost engaged in setting environmental priorities, designing strategies and tracking progress.
- 3. People of color, immigrants and refugees, people with low incomes and limited-English language proficient speakers have opportunities to be leaders and be recognized as part of the mainstream environmental movement.

In April 2016, the Initiative produced an Equity and Environment Agenda for the City of Seattle. This resolution includes the goals included in this agenda, which were crafted with hundreds of community members throughout Seattle.
