1. BILL SUMMARY

Legislation Title: A RESOLUTION relating to the Seattle Department of Parks and Recreation; authorizing submission of application(s) for grant funding assistance for Youth Athletic Facilities (YAF) project(s) to the Recreation and Conservation Funding Board as provided in chapter 79A.25 RCW, WAC 286, and other applicable authorities.

Summary and background of the Legislation: This proposed legislation authorizes the Seattle Parks and Recreation (SPR) to submit grant applications to the State of Washington Recreation and Conservation Office (RCO) for state funding assistance in the amount of \$250,000 to support renovation of the Brighton Playfield and \$250,000 to support renovation of the Smith Cove Playfield. This resolution is required as part of the formal RCO grant application process. Improvements funded by the RCO grant and City match are:

<u>Brighton Playfield Renovation</u>: Renovate/replace an existing 200,000 SF lighted multi-sport natural turf playfield with a new 200,000 SF synthetic all-season multi-sport playfield (supporting, baseball, softball, soccer, lacrosse and other field sports or leisure play). In addition, new LED lights will replace existing lighting, new accessible pathways and spectator seating will be added.

<u>Smith Cove Playfield Renovation</u>: Renovate an existing 5.6 acre natural turf multi-sport playfield with drainage, irrigation and an updated natural grass system. Additional amenities will include accessible pathways and spectator seating.

SPR applies for RCO grants each year and has garnered a strong success rate in securing additional funding for planned capital projects. In 2016, SPR will complete two RCO applications in the Youth Athletic Facilities (YAF) program. The total funding request will be \$250,000 for each project, totaling a \$500,000 funding request in the YAF category.

The RCO grants require a local match, and will fund only projects that are included in SPR's comprehensive plan (Seattle Parks and Recreation Plan 2000). The recommended projects meet both criteria. SPR's required matching funds for the Brighton Playfield and Smith Cove Playfield Renovations are appropriated in Seattle Parks and Recreation's 2016-2021 Capital Improvement Program.

RCO will announce the grant award recommendations in November 2016, but the actual grant awards will not be allocated until 2017. Project planning and design for Brighton Playfield and Smith Cove Playfield projects is anticipated to begin in 2016 with construction planned to start in 2017 after a contract for the grant funding has been fully executed. RCO funding will support

currently unfunded project elements.
