**Title:** AN ORDINANCE relating to City streets; changing the name of Broad Street between 9th Avenue N and Westlake Avenue N to Roy Street, of Warren Place between Warren Avenue N and its east terminus to Warren Place N, of S Della Street between 27th Avenue S and Martin Luther King Jr. Way S to S Walden Street, of Cloverdale Place S between Rainier Avenue S and Seward Avenue S to S Cloverdale Place, of NW 35th Street between 1st Avenue NW and NW Canal Street to NW Canal Street, of 1st Avenue NW between the south margin of N Canal Street and N 35th Street to N Canal Street, of a lower roadway at the east of the present existing bridge on Eastlake Avenue NE between its south terminus at the shoreline and the south margin of NE Pacific Street to Eastlake Place NE, of a lower roadway at the east of the present existing bridge on Eastlake Avenue NE between the north margin of NE Pacific Street and the south margin of NE 40th Street to Eastlake Place NE; correcting and confirming the name and location of NW 114th Street between NW Carkeek Park Road and NW 116th Street as NW 114th Street; naming the alley in Blocks 2, 3, and 4, Seaboard Addition to the City of Seattle, as 30th Avenue SW; naming the alley in Block 19, Denny-Fuhrman Addition to the City of Seattle, as Yale Terrace E; and superseding Ordinance 102981 to the extent inconsistent.

**COUNCIL BILL** 118732

AN ORDINANCE relating to City streets; changing the name of Broad Street between 9th Avenue N and Westlake Avenue N to Roy Street, of Warren Place between Warren Avenue N and its east terminus to Warren Place N, of S Della Street between 27th Avenue S and Martin Luther King Jr. Way S to S Walden Street, of Cloverdale Place S between Rainier Avenue S and Seward Avenue S to S Cloverdale Place, of NW 35th Street between 1st Avenue NW and NW Canal Street to NW Canal Street, of 1st Avenue NW between the south margin of N Canal Street and N 35th Street to N Canal Street, of a lower roadway at the east of the present existing bridge on Eastlake Avenue NE between its south terminus at the shoreline and the south margin of NE Pacific Street to Eastlake Place NE, of a lower roadway at the east of the present existing bridge on Eastlake Avenue NE between the north margin of NE Pacific Street and the south margin of NE 40th Street to Eastlake Place NE; correcting and confirming the name and location of NW 114th Street between NW Carkeek Park Road and NW 116th Street as NW 114th Street; naming the alley in Blocks 2, 3, and 4, Seaboard Addition to the City of Seattle, as 30th Avenue SW; naming the alley in Block 19, Denny-Fuhrman Addition to the City of Seattle, as Yale Terrace E; and superseding Ordinance 102981 to the extent inconsistent.

WHEREAS, the Seattle Police Department and Seattle Fire Department agree that renaming these streets would improve wayfinding and reduce response time for emergency vehicles, and

WHEREAS, the U.S. Postal Service, City departments and utilities have reviewed the proposal and agree that no significant, negative impacts would result from this proposal, NOW,

THEREFORE,

**BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

Section 1. The name of a portion of Broad Street between 9th Avenue N and Westlake Avenue N is changed to Roy Street, superseding prior ordinances to the extent inconsistent.

1 Section 2. The name of a portion of Warren Place between Warren Avenue N and its east  
2 terminus, located in H.A. Raser's Addition as recorded in Volume 24 of Plats, page 35, is  
3 changed to Warren Place N.

4 Section 3. The name of a portion of S Della Street between 27th Avenue S and Martin  
5 Luther King Jr. Way S, located between Blocks 1 and 2 in plat Cascade View Addition as  
6 recorded in Volume 15 of Plats, page 75, is changed to S Walden Street.

7 Section 4. The name of a portion of Cloverdale Place S between Rainier Avenue S and  
8 Seward Avenue S is changed to S Cloverdale Place, superseding Ordinance 105740 to the extent  
9 inconsistent.

10 Section 5. The name of a portion of NW 35th Street between 1st Avenue NW and NW  
11 Canal Street, located between Block 51 and Block 50, Denny and Hoyt's Addition, as recorded  
12 in Volume 2 of Plats, page 136, is changed to NW Canal Street, superseding prior ordinances to  
13 the extent inconsistent.

14 Section 6. The name of a portion of 1st Avenue NW between the south margin of N  
15 Canal Street and N 35th Street, located between Block 47 and Block 50, Denny and Hoyt's  
16 Addition, as recorded in Volume 2 of Plats, page 136, is changed to N Canal Street, superseding  
17 prior ordinances to the extent inconsistent.

18 Section 7. The name of a lower roadway at the east of the present existing bridge on  
19 Eastlake Avenue NE, between its south terminus at the shoreline and the south margin of NE  
20 Pacific Street, is changed to Eastlake Place NE, superseding Ordinance 61346 to the extent  
21 inconsistent.

22 Section 8. The name of a lower roadway at the east of the present existing bridge on  
23 Eastlake Avenue NE, between the north margin of NE Pacific Street and the south margin of NE

1 40th Street, is changed to Eastlake Place NE, superseding Ordinance 61346 to the extent  
2 inconsistent.


3 Section 9. The name of a portion of NW 114th Street between NW Carkeek Park Road  
4 and the northwest corner of Lot 51 of Schroepfel Park as recorded in Volume 35 of Plats, page  
5 12, as identified by Noonan's Addition as recorded in Volume 56 of Plats, page 41, is confirmed  
6 as NW 114th Street, confirming and clarifying the boundary of NW 116th Street at that same  
7 point, and superseding Ordinance 89910 to the extent inconsistent.

8 Section 10. The alley located in Blocks 2, 3, and 4, Seaboard Addition to the City of  
9 Seattle, as recorded in Volume 14 of Plats, page 43, is named 30th Avenue SW.

10 Section 11. The alley located in Block 19, Denny-Fuhrman Addition to the City of  
11 Seattle, as recorded in Volume 7 of Plats, page 34, is named Yale Terrace E.

1 Section 12. This ordinance shall take effect and be in force 30 days from and after its  
2 approval by the Mayor, but if not approved and returned by the Mayor within ten days after  
3 presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.
