The Council requests that the Seattle Department of Transportation manufacture, install, and maintain honorary signs at the intersections of South Jackson Street and 20th Avenue South, South Jackson Street and 20th Place South, South Jackson Street and 22nd Avenue South, and South Jackson Street and 23rd Avenue South, which shall reflect the "Ernestine Anderson Way" honorary designation.

Section 3. By this resolution, the Council does not intend to affect any existing or future signage that reflects the honorary designation of "Ernestine Anderson Way" with the exception of the signs described in Section 2 of this resolution.
