**Subject:** Ongoing Discussion of Potential Amendments to Seattle 2035

On September 9, the Planning, Land Use and Zoning (PLUZ) Committee will continue discussion of amendments to the Mayor's Recommended Comprehensive Plan, "Seattle 2035."

The purpose of this memo is to set out potential amendments, some informed by previous discussion and some new, for your consideration. Amendments are shown on attachments.

Action by the PLUZ Committee on amendments will occur no earlier than September 20. PLUZ will hold a hearing on Seattle 2035 and potential amendments by Council to the Mayor's proposal on September 15.

## **Background on Committee Process**

Leading to the previous PLUZ discussion on August 16, Councilmember Johnson took the Comprehensive Plan "on the road," bringing key themes of the plan to most Council committees for review and discussion over a period of two months. The attached list of potential amendments comes out of those discussions. It also includes recommendations by the Seattle Planning Commission, the Seattle Music Commission, Historic Seattle and others. Many of the ideas in the attached amendments are informed by comment and testimony from members of the public, received both at the public hearing on June 27 and in written comments.

## **Proposed Amendments – Form and Content of Attachments**

Attachments 1 through 14 share a common structure. These attachments list amendments by Comprehensive Plan Element. Each Element's list is broken into "policy decisions" and "technical amendments." Potential amendments that address larger themes or where a range of options are provided are listed as policy decisions. Policy decisions have already and will likely continue to be of most interest to PLUZ for discussion.

More targeted and/or simpler amendments are included as technical amendments. Please let us know if you'd like to discuss the technical amendments in more detail or if you would like to consider alternatives to the potential technical amendments, and we will work with you to identify those alternatives or provide additional information, if necessary.

The initial form of each amendment is shown along with discussion and the Council's draft amendment. *All of Council's amendments should be considered draft*, pending the public hearing on September 15 and further discussion.

Attachments 15 through 19 cover a range of issues. They each stand alone because their length and/or content does not fit well into the "policy decisions" and "technical amendments" format shared by Attachments 1 through 14.

The attachments altogether, except Attachment 19, are intended to constitute a complete, second draft of amendments that the Council may consider. Throughout all of the amendments, specific language to be deleted is shown in strikethrough and specific language proposed to be added is shown <u>underlined</u>. Three asterisk marks (\*\*\*) are used to show the omission of content adjacent to amendments. Please let us know if we can provide additional information about any of these amendments.
