## II. <u>Annual Fee Assessment:</u>

The 2016 permit fee is calculated as follows:

(\$272/SF) X (825 SF) X (75%) X (8%) = \$13,474.93 where 75% is the degree of alienation for a semi-private-use skybridge and 8% is the annual rate of return.
