The current fees are not sufficient to cover FAS' costs to regulate the industry, requiring GSF support to FAS of approximately \$167,000 in 2016. The new fees proposed by the Mayor (\$1,500 and \$750) would still require GSF support to FAS to regulate the industry. The fees proposed here would fully cover the direct and indirect cost of regulation and free up \$429,752 in GSF support to FAS in 2017 and \$436,993 in 2018.
