1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to the financing of the Central Waterfront Improvement Program; amending Ordinance 124345 to extend the duration of the interfund loan to be used for this capital program and establishing the Transportation Master Fund as the lending fund.

Summary and background of the Legislation: This legislation extends the current interfund loan for the Central Waterfront program through 2019. It does not increase the amount of the interfund loan authorized in Ordinance 124345. Responsive to Council Resolution 31553, which adopted and restated City debt management policies, it also establishes the Transportation Master Fund as the loaning fund for the interfund loan. In Ordinance 124345, the loan was against the Consolidated City Cash Pool, which does not comply with the updated policies.

The interfund loan was created to fund the design of the Central Waterfront improvements prior to formation of the planned Local Improvement District (LID) and the issuance of bonds tied to the LID. Ordinance 124345 anticipated that the interfund loan would be repaid by the end of 2016. Design of the Central Waterfront improvements and formation of the Local Improvement District have been delayed because of the problems with the SR 99 Bored Tunnel project. This legislation is necessary to allow the design process to continue to and to provide the necessary time to allow for formation of the LID.
